LIMITED WARRANTY DEED

THIS INDENTURE, made this 2nd day of July, 1987, between SOUTHEAST HOLDING COMPANY, LTD. f/k/a BIG CANOE CORPORATION (herein called the "Grantor"), a South Carolina corporation, and THE BYRNE CORPORATION OF GEORGIA (herein called the "Grantee"), a Georgia corporation;

WITNESSETH that, in consideration of Ten Dollars (\$10.00) in hand paid and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby transfer and convey unto Grantee all Grantor's right, title and interest in and to the land described in <a href="Exhibit" "A" attached hereto and made a part hereof, together with all buildings and other improvements located thereon, and together with all rights, members and appurtenances in any manner appertaining or belonging to said property;

TO HAVE AND TO HOLD said property unto Grantee in fee simple absolute forever, subject, if and as currently applicable, to those rights, easements and other matters set forth in <a href="Exhibit" "B"" attached hereto and made a part hereof. Grantor shall warrant and forever defend the right, title and interest to said property unto Grantee against the claims of all persons claiming by, through or under Grantor, to the extent that such claims have accrued subsequent to October 1, 1977, except for those matters, if and as currently applicable, set forth in <a href="Exhibit" "B" attached hereto and made a part hereof. Where the context requires or permits, "Grantor" and "Grantee" shall include their respective heirs, successors and assigns.

Grantor does hereby likewise transfer to Grantee, its successors and assigns, all of its rights, privileges and immunities as the "Company" and the "Developer" as those terms are used in the General Declaration of Covenants and Restrictions of the Big Canoe Property Owners Association and Big Canoe Corporation, as amended, which is referred to in Exhibit "B" attached hereto and made a part hereof, ("Declaration"), and as used in the Articles of Incorporation and By-laws of the Big Canoe Property Owners Association, Inc., and Grantor does likewise hereby designate Grantee as the "successor developer" as that term is used in Section 8.07 of that certain Settlement Agreement Among Southeast Holding Company, Ltd. and Big Canoe Property Owners Association, Inc., et al. Dated March 31, 1987.


